

William Tritton (1785-1843) was baptized in Chartham on 3 May 1785, the son of Henry Tritton. He was first cousin of William Tritton (1768-1837) in plot 595. William was a tailor in Great Conduit Street, Hythe.

Charles Tritton was the second child of William and Arabella Tritton. He was born and died in 1811

Arabella Tritton nee Davidson married William Tritton at Addington on 7 December 1809. They had four children, William (1810-1875), Charles (1811-1811), Anne (1816-1870) and Alfred Davidson Tritton (1819-1887). His sister Mary is buried in plot 596.

John Horton was the son of John Horton and Mary Price who are buried in plot 597. John junior was baptised in Hythe on 20 February 1771. He married Mary Oldfield in Hythe on 3 May 1796. They had nine children, all baptised in Hythe, Mary (March1799- died October 1818), John (July 1800), Henry (August 1802), Jane (December 1804), Sarah (March 1807), Eliza (April 1809), Elizabeth (November 1810), Charles (May 1812), and Harriet (April 1816). John Horton was a bricklayer, like his father. In 1841 he and Mary were living in Chapel Street, Hythe, with their daughter Elizabeth.

Mary Horton nee Oldfield was baptised in Lyminge on 14 July 1776, the daughter of William and Catherine Oldfield.

Plot 609 Cross

Inscription In memory of/ Mary/ wife of Samuel Cross/ who died March 21st 1842/ aged 89 years.

Mary Cross nee Millbourne was the daughter of James & Elizabeth Millbourn; she was baptised in Folkestone in December 1775. She married Samuel Cross, a widower, in Hythe on 9 April 1798. In 1841 they lived in Bartholomew Street, Hythe and Samuel, then aged 75, was a labourer

Plot 610 Smith

Also/ to his daughter/ [line illegible]/ who died ... January 1833/ aged 27 years.

Also to his [grandson] / [Archimedes Petit] Smith/who died 5th of August 18[4]8/ aged 7 years.

Charles Smith was for many years the postmaster in Hythe. He was also an undertaker, a newsvendor and agent for the Kent Fire and Life Office. In the early part of the 19th Century the post office was in the same premises in Hythe High Street as it is today (2015), marked by a plaque recording the birth there in 1808 of his son Francis Pettit Smith, the inventor of the screw propeller for ships. Charles Smith was born in Kent in 1770. On 19 December 1795 he married Sarah Pettit in Hythe. They had Francis in 1797 who had, presumably, died before Francis the inventor was born. Mary Anne was born in 1803 and Charlotte in late 1805. By the 1841 census Charles Smith had retired and his daughter had taken over as postmistress.

Charlotte Boby nee Smith had married William Johnson Boby 25 January 1831 in Hythe.

Archimedes Pettit Smith was born in London, the third child of Francis Petitt Smith and his first wife Ann nee Back. He had the same name as his father's first commercially produced ship, the SS Archimedes

Plot 611 Castle and Monypenny

Inscription Sacred to the memory of Thomas Castle Esquire/ late of Ingles in the Parish of Folkestone/ who died October 29th 1825/ in the 78th year of his age/ leaving a widow and two children/ viz Thomas and Jane.

Also of Jane relict of the above named/ Thomas Castle who died May 17th 1832 in her 77th year.

In/ memory of Jane the wife of/ Phillips Monypenny Esq./ of this Town and daughter of/ Thomas and Jane Castle/ who departed this life June/ 15th 1850 in the 53rd year/ of her age.

..... Thomas Castle Esquire/ of Ingles in the Parish of Folkestone/ [who died] ... 1826/ [in the ... year] of his age/ leaving [a widow] and two children/ An...... and George E[lphi]cke

Also of Thomas son of the above/ who was accidentally drowned in the River Medway/ April 30th 1830 the tenth year of his age.

Thomas Castle (1748-1825) was born in Folkestone and baptised there on 28 October. He was the son of Thomas Castle by his second wife Ann Lewis.. Thomas Castle Senior lived most of his life at Ingles Farm in Folkestone but had moved to Hythe by September 1824 when he made his will. In his will he described himself as a Gentleman but for most of his life he was a yeoman farmer. He was still an active farmer in 1824 and most of his land was on Romney Marsh. He left all his land and all his household goods etc to his wife Jane for life. Jane died in 1832. After her mother's death the household goods etc went to his daughter Jane and she also inherited his house in Hythe occupied by a tenant and 52 acres of land in Burmarsh and 6 acres of land in Hythe. On his wife's death the rest of land, comprising 145 acres of fresh marsh land near New Romney which he occupied and 10 acres of land in Folkestone occupied by his son Thomas,

were to go to his son Thomas but Thomas predeceased his mother.

Jane Castle and her husband Thomas had two children, Thomas (b.1794) and Jane (b.1798)

Thomas Castle (1794-1826) was baptised on 11 April 1794 in St Mary & St Eanswythe, Folkestone. He lived at Ingles Farm, Folkestone and was a grazier. He married Ann Elphicke in Tenterden in 1816. They had three children, all baptised in Folkestone, Ann in 1819, Thomas in 1821, and George Elphicke in 1824. He left his property to his wife Ann for life and after her death to his children. His executors were two of his friends who were graziers and he directed them to continue his business as a grazier

Jane Monypenny nee Castle was the daughter of Thomas Castle Senior. On 21 June 1831 she married Phillips Monypenny in Hythe. They had no children. They lived in Hythe High Street in 1841. Jane died on 25 June 1850. In 1855 Phillips bought Oak Hall in Bartholemew Street where he lived with his older sister Mary Judith Moneypenny. In 1864 he sold Oak Hall and moved to Northfleet where he died in 1875.

Thomas Castle (1821-1830) was the son and second child of Thomas Castle junior referred to above.

Plot 618 Geere

Inscription To the memory of/ Elizabeth Geere/ wife of John Geere Gent/ who departed this life August 1798/ aged 77 years.

To the memory of/ [John Geere] Gent late of this town/ [who departed this life] February 1[791]/ illegible.

Elizabeth Geere and her husband had only one child, Elizabeth, who married Charles Bridges of Hythe, Surgeon, then Robert Jones of Hythe, Surgeon, by whom she had a son John Geere Jones. Robert Jones died when John was about 11 months old and Elizabeth married Benjamin Fenner of Smeeth whom she outlived.

John Geere was born in Horsham on 21 October 1720 and baptised in the Baptist Chapel. His father, also John, was a leading member of the General Assembly of the General Baptist Churches in England and John junior was a member in the 1770s. John Geere was a freeholder of land in New Romney and entitled to vote in Parliamentary elections

<u>**0>?**</u> The baptisms of Mary Ann, Louisa and Emily have not been found. Another daughter, Margaret (Sedgwick), pre-deceased the couple and is buried in plot 628. After Thomas's death Mary and Emily continued to live together, both with independent means. Mary Marshall appears in the list of 'Gentry' in an 1858 directory. Her parents are buried in Plot 743 and her sister Elizabeth in plot 729

Plot 619 Andrews/Mackenzie/Douglas/Snodgrass

This is an altar tomb with inscriptions on all five visible sides, so it has been treated as five separate inscriptions as follows:-

A) Andrews.

Inscription-Top of the tomb Here lie interred the remains of Ann the wife of Edward Andrews Gent who died 22nd September 1766 aged 64 years. Also of Edward Andrews who died 11th January 1770 aged 63 years leaving four children by his said wife namely Edward, Robert, Ann and Mary. Also Edward Andrews, son of Robert and Rachel Andrews who died June 4th 1774 aged eight months. Likewise of Edward Andrews of the Town and Port of Dover, Gent, and son of the above named Edward and Ann Andrews who died 29th August 1798 aged 63 years. Also of Robert Andrews of this Town and Port, Gent, who died 1st January 1801 aged 63 years leaving one daughter Rachel. Rachel wife of Robert Andrews died 22nd December 1803 in the 67th year of her age and is here interred. Also of Donald Douglas who died at Hythe September 30th 1883 aged 62 years. [The above transcript was made by Mr L.L. Duncan in 1891; the top inscription is now weathered and difficult to read].

Edward Andrews (1707-1770) was baptised in St Mary's, Dover, on 3 June 1707, the son of Samuel & Judith Andrews. He married Anne Hammond in Hawkinge on 18 October 1729. They had five children. Four were baptised in Hythe, Ann in 1731, Elizabeth (who died young) in 1732, Mary in 1733 and Robert in 1737; Edward was born c.1735. Edward Andrews died on 4 January 1770 in his house in Hythe, aged 63.

Ann Andrews nee Hammond was probably the daughter of Richard & Mary Hammond who was baptised in Petham on 28 March 1708.

Edward Andrews (c.1735- 1798), the elder son of Edward & Ann Andrews, probably never married. He was a tanner in Dover. When he died in 1798 he left all his property to his brother Robert.

Robert Andrews, the younger son of Edward & Ann Andrews was baptised in Hythe in 1737. He married Rachel Child in Sellinge on 28 April 1772. They had two children. Edward, christened in Hythe in October 1773, was buried there in June 1774. Their daughter, Rachel, was baptised in Hythe

on 16 April 1782. She married Colonel (later General) Kenneth Mackenzie (later Douglas) in Hythe in 1804 (see further below). Robert Andrews owned freehold land in Hythe so could vote in Parliamentary elections.

Rachel Andrews nee Child, the wife of Robert Andrews, was born c.1737 andmarried Robert Andrews in Sellinge in 1772. She died in 1803.

B) Mackenzie/Douglas

Inscription- South side In the vault are deposited the remains of Lieutenant General Sir Kenneth Douglas Baronet of Glenberrie Colonel of the 58th Regiment eldest son of Kenneth Mackenzie Esquire of Kilcoy Castle Rossshire. He entered the Army at the age of 13 and served his King and Country whenever called until his death which took place in London November 22nd 1833 aged 69 years. He assumed the name and Arms of Douglas by sign manual on the 19th October 1831 in memory of his uncle Sir Alexander Douglas of Glenberrie. He married on the 18th December 1804 (when Lieutenant Colonel Mackenzie of the 52nd Regiment) Rachel only daughter of Robert Andrews Esquire of this Town and Port by whom he had nine children and left surviving six viz: Robert Andrews, Alexander Douglas, Edward, Rachel, Lynedoch and Donald. Kenneth and William died in their infancy and Kenneth his third son died in Ceylon.

General Sir Kenneth Mackenzie-Douglas was born in 1754, the eldest son of Kenneth Mackenzie of Kilcoy, Rossshire and his wife Janet, the daughter of Sir Robert Douglas, 6th Baronet of Glenbervie. He was created Baronet of Glenbervie in 1831 when he changed his name from Mackenzie to Douglas. In 1767 he entered the Army as an ensign in the 33rd Regiment in Guernsey and in 1783 transferred as a lieutenant into the 14th Regiment in the West Indies. In 1791 his Regiment went to the Netherlands and he served throughout the 1793 campaign. His qualities as an officer impressed Thomas Graham of Balgowan (later General Lord Lynedoch) who asked for his services when he raised the 90th (Perthshire Light Infantry) Regiment in 1794 during the French Revolutionary War. Lt Mackenzie was promoted Captain and Major in the 90th which became the oldest British light infantry unit. In 1795 it landed in Brittany to support a French Royalist force in the Quiberon campaign. It then went to Portugal where he became acting Lt-Colonel and his battalion was used By Sir Charles Stuart as a role model for other officers. Mackenzie took part in the capture of Minorca in 1798, was promoted Lt-Colonel and became acting Adjutant-General of the island. In 1801 he went with the 90th to Egypt as a Major as part of the British Expeditionary Force to drive Napoleon out of Egypt. The 90th sustained heavy casualties in the Battle of Mandora in March 1801and Mackenzie took command when the Colonel was killed. He commanded the 44th Regiment in Egypt and then Gibraltar till 1804 when he took command of the 52nd Regiment in Shorncliffe.

Shorncliffe Camp in 1804 was commanded by General Sir John Moore and it was there that the famous Light Division of Peninsular fame was trained. Sir John Moore was the driving force behind the innovative training regime but Mackenzie put it into practice. In 1804 he married Rachel, daughter of Robert & Rachel Andrews in Hythe. He suffered concussion from a fall from his horse and had to retire for a time but in 1808 he was promoted Colonel and went to Cadiz to command a brigade for a short time till ill-health forced him to return to England. In 1811 he was promoted Major-General and appointed to command all the light infantry troops in England. In 1813 he went to the Netherlands and was Governor of Antwerp in 1814-5. He then retired to Hythe. He was promoted Lt-General in 1811. During his retirement he became a jurat in Hythe and was active in the

campaign in Hythe for Parliamentary Reform in the early 1830s when most of those entitled to vote in Hythe did not live there and many inhabitants and ratepayers had no vote.

C) Douglas/Snodgrass

Inscription-North side Within this vault are deposited the remains of Rachel Douglas relict of Lieutenant General Sir Kenneth Douglas Baronet who departed this life on the 24th January 1847 aged 64. To the memory of Sir Robert Andrews Douglas Baronet of Glenberrie Major 12th Regiment who died in Mauritius November 1843 aged 36. To the memory of Alexander Douglas Douglas Esquire late Lieutenant 68th Regiment who died in London on 6th May 1848 aged 38 and was buried in Kensal Green Cemetery. To the memory of Rachel Douglas widow of Major Snodgrass 96th Regiment, died January 15th 1877.

Rachel Mackenzie-Douglas was the only child of Robert & Rachel Andrews to survive infancy. She was born in 1787 and married Kenneth Mackenzie-Douglas in 1804 (see above). She bore him 8 sons and one daughter, Rachel, who married John Snodgrass.

Robert Andrews Douglas was the eldest son of General Sir Kenneth Mackenzie-Douglas and inherited the baronetcy. He married Martha Elizabeth Rouse on 29 April 1835 at St George's Hanover Square. They had three children. He served as a Major in Her Majesty's 12th Regiment of Foot. He died of TB on 1 November 1843 and is buried in the graveyard at Port Mauritius.

Alexander Douglas Douglas was born on 22 December 1811, the son of General Sir Kenneth Mackenzie-Douglas. He married Anne Rouse (the sister of Martha Elizabeth Rouse who married his brother Robert) on 17 April 1834. They had two sons and three daughters.

Rachel Douglas Snodgrass was born in 1817, the daughter of General Sir Kenneth Mackenzie-Douglas. She married her cousin John Snodgrass, an officer in the 96th Regiment, who died in 1856. After his death she went with her three children to live in Jersey. She moved to Weston-super-Mare and then to Cardiff where she died in January 1877. She left under £600 and her two unmarried daughters were her executors.

D) Douglas

East end In memory of Edward Douglas Ensign 53rd Regiment died November 9th 1833 aged 20. Also of Donald Douglas died September 30th 1885 aged 62 sixth and eighth sons of Lieutenant General Sir Kenneth Douglas Baronet of Glenberrie, both of whom died at Hythe and are interred in this vault.

Edward Douglas – no further information

Donald Mackenzie Douglas was born on 7 July 1821. He married Emily Jane Kennedy 5 August 1847. They had a daughter and two sons. He was a Captain in the Royal North Down Rifles

E) Mackenzie

West end In memory of Kenneth Mackenzie Lieutenant 58th Regiment third son of Lieutenant General Mackenzie who died and was buried in Ceylon aged 20 years and ten months. Lyndock fifth son of the above died in Jersey 15th May 1859 aged 41 years.

Kenneth Mackenzie Douglas was born on 14 July 1809. He did not marry.

Lyndoch Mackenzie Douglas was born on 28 October 1818. On 26 July 1848 he married Laura Susanna, youngest daughter of Lieutenant-General Sir Archibald Campbell, Baronet, G.C.B. They had three children. Lyndoch was a lieutenant in the army.

Also/Mary, relict of the above/who died 30th July 1861/aged 83 years.

Thomas Marshall was the son of Mark and Katharine Marshall and was baptised in Brabourne, Kent. He was half-brother of Samuel in plot 627. Thomas was also a butcher. Jane and Emily were living with their parents in Hythe High Street in 1841 and Thomas was active as a butcher. In 1851 he described himself as a grazier.

Mary Marshall nee Stokes was the daughter of Edmund and Jane Stokes. She was baptised in Lyminge on 16 August 1778 and married Thomas Marshall in Hythe on 6 October 1801. Their son John was baptised in Hythe in January 1802, followed by Elizabeth in on Christmas Day 1803, Thomas in November 1805 and Jane in July 1808. The baptisms of Mary Ann, Louisa and Emily have not been found. Another daughter, Margaret (Sedgwick), pre-deceased the couple and is buried in plot 628. After Thomas's death Mary and Emily continued to live together, both with independent means. Mary Marshall appears in the list of 'Gentry' in an 1858 directory.

Plot 627 Marshall

Inscription In memory of/ Samuel Ma[rshall]/ illegible/ Also on his right lieth the body of/ Sarah his widow who died 2nd of/ Nov 1834 aged 68 years/ She left surviving 1 son.

Samuel Marshall was a butcher. He was the son of Mark (also a butcher) and Martha Marshall and was baptised in Brabourne, Kent, on 11 November 1763. His mother died in 1766 and his father married Katharine Warrington in Stouting on 9 October 1767. By 1791 Samuel had moved to Hythe where, as a freeholder, he voted in Parliamentary Elections. On 17 February 1795 he married Elizabeth Gilbert of Stanford in Lyminge. Their first child John was baptised in Hythe in September 1796, followed by William in 1798, and George in 1800. Elizabeth Marshall died in December 1805. He then married a lady called Sarah. His half-brother is buried in plot 621

Plot 628 Sedgwick

Margaret Sedgwick nee Marshall was baptised in Hythe on 30 June 1811 and married Thomas Sedgwick there on 19 April 1838. He was a fruiterer. Her parents are buried in plot 621

Marshall Thomas Sedgwick was baptised in Saltwood on 9 January 1840 and buried in St Leonard's on 28 February 1840.

Margaret Jane Sedgwick was the twin of Marshall Sedgwick. She was baptised on the same day and was buried on 20 January 1840

Margaret Hope nee Sharp married William Hope in Hythe on 8 February 1762. They had six sons, all baptised in Hythe. William was baptised in 1762, John in 1764, Joseph in 1766, Thomas in 1769, Cornelius in 1771 and James in 1773.

George Hilton/ died 10th December 1847 aged 28 years.

Footstone [C] H/ 1846/ G H/ 1847

Caroline Hilton nee Kennett was one of the eight children of Gilbert and Ann Kennett. She was christened in Faversham on 23 July 1821. Her father was the licensed victualler of the White Horse in Faversham in the 1830s and then ran the Golden Lion in Gillingham from 1838 till he retired after 1851. Caroline married George Hilton in Gillingham on 6 September 1841. They lived in Hythe where Caroline died of TB in 1846.

George Hilton was born c.1821, probably in Sellinge, the eldest child of Stephen and Mary Hilton. Stephen Hilton was a Naval Officer who was Masters Mate of HMS Minotaur in Nelson's Squadron at the Battle of Trafalgar. Stephen brought back as prizes the Union Ensign flown by HMS Minotaur in the battle and the ensign of the Spanish warship the Neptuno which HMS Minotaur captured. He used his Prize Money to build Trafalgar House in Sellinge. George was a grocer in Hythe High Street where his two daughters were born. After Caroline died George took to drink. In March 1847 he was made bankrupt and in December 1847 he died in the Guildhall Tavern in Folkestone after taking rat poison. The coroner's verdict was that 'he destroyed himself during a fit of temporary insanity'. His elder daughter Ann Mary died of TB in 1868 aged 25. The younger, Emily Jane, died in 1859 of a brain infection in King's College Hospital.

Susan Whitehead nee Knight married Thomas Newton Whitehead in St Pancras Church, London, on 31 March 1824. He died in 1847; in his will, proved 23 July 1847, he described himself as 'Gentleman of Shenley, Herts', Susan Whitehead described herself in her will, proved 2 May 1855, as 'widow of the Village of St Stephen, Herts'.

Margaret Gill, born in Kent c.1763, was the wife of John Gill, a surgeon, born in Kent c.1760. She bore him 6 children, Mary (1790), George (1791), Charles (1793), Catherine (1795), Leonora (1797) and Helen (1799). All were baptised in Folkestone. John Nelson Frampton was born in Dorchester, Dorset, in 1799, the son of George & Ann Frampton. By 1815 he was a 2nd-Lt. in the Rifle Brigade.. In 1841 the family lived in Prospect Place, Hythe, but later moved into the High Street.

Lucy Frampton nee Shipdem was born in Dover on12 September 1800, the daughter of John & Frances Shipdem. Her father was Town Clerk and Harbour Registrar of Dover in the 1820s and Mayor in 1836. On 17 July 1832 she married John Nelson Frampton in St James, Dover. She bore him three children, Ellen Frances born 28 April 1833 and William John born in 1839, both in Dover, and Thomas born in 1841 in Hythe. Lucy was buried in Dover on 10 November 1856.

Ellen Frances Frampton was born in Dover in 1833 and lived with her parents till their deaths. After her mother died she continued to live in the High Street, initially with her brother Thomas, till her death on 27 September 1883. She left personal estate worth £6,631. Her brother William, Lt-Colonel of the East Lancashire Regiment, was Administrator of her estate.

John Puckle was born in Icklesham in 1725, the son of John Puckle (1696-1743) and Frances Curtis (1700-1727). John owned a freehold house in the West Ward of Hythe which entitled him to vote in Parliamentary Elections. By 1802 when he made his will only two of his daughters were alive; he left his house and the contents plus £2000 in trust to his wife for her life and then to Sarah and Christian for their lives. He left £1,250 each to Sarah and Christian and the remainder of his estate to his four sons, John (1750-1819), Thomas (1752-1814), Robert (1758-1832), and William (1762-1826)- see below. John and Thomas had a warehouse business in the City of London and Robert was a woollen draper in Cornhill, City of London

Elizabeth Puckle nee Scoones was the daughter of Thomas & Mary Scoones. She was born in Tonbridge in October 1724 and married John Puckle there on 22 August 1749. Their first child, John, was born in Tonbridge but the other eight were born and baptised in Hythe

Mary Puckle was the eldest daughter of John & Elizabeth Puckle. She was baptised in Hythe on 22 February 1754 and buried there on 29 May 1771.

B&C Both inscriptions *To/* the memory [rest illegible].

These two gravestones are identical to the three Puckle gravestones either side of them. One must be the grave of John & Elizabeth Puckle's son, William Puckle, and his widow Ann Puckle and the other the grave of John & Elizabeth's two youngest daughters, Sarah Puckle and Christian Puckle.

William Puckle was the youngest son of John & Elizabeth Puckle. He was baptised in Hythe on 21 December 1762. He married Ann Bradley in St Thomas, Portsmouth, on 6 April 1794. William was a hosier in Southwark; in August 1795 he took on his brother-in-law, Samuel Bradley, as an apprentice. At the end of his life he and Ann lived in Princes Place, Kennington. They had no children. When he died in Hythe in November 1826 he bequeathed all his property to Ann.

Ann Puckle was the daughter of Joseph and Elizabeth Bradley. She was born on 17 May 1767 and baptised in Godalming, Surrey, on 27 October 1767. Her will made on 4 March 1831 stipulated that she should be buried in Hythe in the same vault as her husband. In that will she made numerous bequests of money and jewellery to her brothers and sisters and their children and to various members of the Puckle family.

Sarah Puckle was baptised in Hythe on 28 September 1760, the seventh child of John and Elizabeth Puckle.

This Lionel Lukin /was the first who built/ a life boat/and was the original inventor of that/principle of safety/by which many lives and much property/have been preserved from shipwreck/and he obtained for it the King's patent/in the near/illegible

Lionel Lukin was the youngest son of William Lukin of Blatches, Little Dunmow and his wife Anne, nee Stokes. While he was working as a London coachbuilder, Lukin began experimenting with a Norwegian yawl in 1784, testing his alterations in the River Thames. He became Master of the Worshipful Company of coachmakers in 1785. In the same year he filed his patent for an 'unimmergible boat'. His boat was designed with air boxes along the sides and a cork belt. His first boat was tried at Ramsgate. In 1786 a boat

converted to his design was used in Bamburgh. The first purpose-built lifeboat was the Frances Ann of Lowestoft. She was in use for 50 years and saved over 300 lives. He also invented a raft for rescuing persons under ice, an adjustable reclining bed for hospital patients, and a rain guage.

He was twice married, and by his first wife, Anne (nee Walker) widow of Henry Gilder of Dunmow, had a daughter, and a son of the same name, who patented several inventions. He married secondly Hesther Clissold of Reading. He retired to Hythe at the age of 82, when his eyesight failed.
