

James Whitehead was the son of Stephen Whitehead and was born in Hythe. He became a coachman. He lived with his family in Windmill Street and Stade Street.

Susannah Hughes Whitehead nee Palmer was born in Sellinge, the elder child of John and Susannah Palmer. She married James Whitehead in the village on 6 April 1856. They had ten children.

Emily Margaret 'Milly' Whitehead was born in Bolton, Lancashire. She was the fourth child of James ans Susannah Whitehead and worked as a dressmaker. She died in Hythe.

May Whitehead was the ninth child of James and Susannah Whitehead. She also worked as a dressmaker and died in Hythe.

Ethel Whitehead was the youngest child of James and Susannah Whitehead. She worked as a draper's shop assistant and died in Hythe.

William Harry Punyer was born in Newington, Kent, the son of Mary Punyer nee Rolfe. She was widowed when William was a baby. William became a bricklayer and married Mary Ann. They had two children and lived in Hythe.

Charlotte Rolfe was the younger sister of Susannah Rolfe, the mother of William Henry Punyer. She was born in Newington and spent her working life in service in Folkestone, before living in retirement with her nephew and his family.

Plot 440 Finn

Also the above named/Jesse Finn/who died the 2^{nd} June 1872/in his 67^{th} year

Mary Ann Finn nee Brett was the daughter of Mary Brett and was born in Mersham, being baptised there on 4 November 1798. She married Jesse Finn on 27 October 1827 in the town. They had one son.

Jesse Finn was born in Mersham. He became a shoemaker and lived in The Street in the town before retiring to Hythe.

Plot 441 Harley

Inscription In memory of/ Henry Harley/ who died 15th March 1880/ in his 6th year

Elizabeth Harley/ died 5th January 1?0? in her 88th year

Henry and Elizabeth Harley were schoolteachers. Henry was born in 1814 in Brabourne, Kent, the son of Dennis & Mary Harley. He married Elizabeth Lucas in Dover in 1839 and by 1841 they were living in Hythe High Street and working as teachers. By 1851 they had a small boarding school in Theatre Street, Hythe, with six pupils living with them. By 1861 they had both retired in their 40s and were living in the Bath House, next to Moyle Tower. In 1871 they were living in Prospect Place and after Henry's death in 1880 Elizabeth continued to live there but as a lodger. Henry left personal estate of 'under £5,000' so she was financially independent till her death in early 1900.

Plot 442 Ashdown

Inscription Edward Ashdown/ born December 23rd 1811/ died October 8th 1855

Edward Ashdown was a tailor in Hythe High Street. He was born in New Romney. In 1841 he

was living in the High Street with his wife Lucy and 1-year old Ferdinand. By 1851 he was employing two men in the High Street and the family lived in Marine Walk Street, Hythe.

Plot 443 Amos

Inscription In/ loving memory/ of/ Joseph Amos/ who departed this life/ 15th of November 1895/ aged 81 years

"Blessed are the dead which die in the Lord"

Also/ of/ Elizabeth Amy/ widow of the above/[wh]o departed this life/ 2nd February 1899/ in her [80?] year/ (illegible) end was peace.

Joseph Amos was baptised in Lympne, Kent, the son of Henry Amos and Mary Waters. On 24 December 1833 he married Mary Godden in St Stephen's, Lympne. In 1841 he and Mary were living in Saltwood with two daughters. His first wife died and in 1849 he married Elizabeth Amy Waters in Saltwood. He and Elizabeth moved from Saltwood to Hythe in about 1852, living first in Chapel Street and then in Theatre Street. They had three sons who survived infancy, Henry, Joseph, and Charles and a daughter, Elizabeth. Joseph had various labouring jobs.

Elizabeth Amy Amos was the youngest child of Thomas Payne and Susanna Wratten. She was born in Saltwood c.1821. In 1843 she married James Waters in Folkestone and had a daughter by him. After his death she married Joseph Amos. She was 79 when she died in 1899.

Plot 444 Gamble

James Henry Gamble. On 17 February 1871 a Regimental Board comprised of three Captains on the staff of the School of Musketry in Hythe was convened 'for the purpose of verifying and recording the Services, Conduct, Character and cause of Discharge of Hospital Sergeant James Henry Gamble' of the 82nd Foot and found him unfit for further service. He was discharged and died within four months. He had served 6 months in Corfu, nearly a year in the Crimea (for which he was awarded the Crimean Medal with clasp for Sebastopol and a Turkish Medal) and nearly a year in India in 1857-58. James Henry Gamble was born in Leicestershire in about 1835. At the age of 16 he was one of 16 labourers on a 450 acre farm in Leicestershire. He joined the Army in about 1854. He married Sarah Vidgeon; she was born in Saltwood in about 1837 but by about 1855 the family had moved to Hythe. By the time of James's death (aged 35) they had four children aged 2 to 9.

Plot 445 Lane

Inscription on cross In loving memory of Charlotte Lane/ who fell asleep/ August (?) (illegible) 1909 aged 77

My peace I give unto you

Inscription on lower side of foot of surround (2 illegible words)

Charlotte Lane was born in Chatham in 1832, the second daughter of John and Mary Lane. In 1851 she was living at home; her father was a hotel keeper in Aldermanbury, City of London. In 1871 Charlotte and her elder sister were governesses living in Hackney but by 1881 Charlotte had moved to Hythe to be housekeeper and companion to Mrs Elizabeth Constantine in Arthur Villa, Stade Street. She continued to live with Mrs Constantine till her death on 3 August 1909. Charlotte left £943.

Inscription Sacred to the memory of/ RIP/ Jane Pilcher/ who departed this life/ June 9th 1909/ aged 78.

Also Amanda Malvina Hammon/ dearly beloved wife of/ Philip Theodore Hammon/ nephew of above/ who passed away November 10th 1941

And in loving memory of/ the above/ Philip Theodore Hammon/ who passed away July (illegible).

Jane Pilcher was born in Sibertswold (now called Shepherdswell) in 1831, the third daughter of John and Sarah Pilcher. Her father was a blacksmith. After her parents died she was housekeeper to a succession of relations. Her widowed mother was a grocer in Sibertswold. In 1871 she was living with her cousin Frederick Crux who was a grocer and tallow chandler in King Street, Ramsgate. By 1881 another cousin, Pilcher Page (born in Hythe) had taken over the grocer's business in King Street. By 1891 Jane was no longer living in Ramsgate and by 1901 she was housekeeper to her nephew, Philip Theodore Hammon at 32 High Street, Hythe. She stayed there till her death in 1909. Philip (by then a jeweller's manager) was her executor. She left £341.

Philip Theodore Hammon was the second son of John Green Hammon and Elizabeth Ann Pilcher. He was christened on 5 June 1864. His father was a farmer in Pedlinge. In 1861 he was farming 97 acres and employing 3 men; by 1881 he was farming 170 acres and employing 5 men and 2 boys. Philip and his older sister Laura (who married Llewellyn Wood and is buried with him in Plot 243) was sent to a school in Nonington run by a mother and her two daughters. By 1861 Philip had become apprenticed to a watchmaker, probably in Hythe, since he was living at home in Pedlinge . By 1891 he had become a journeyman jeweller, living in Hythe High Street. In 1901 and 1911 he was a jeweller's assistant, living at 32 High Street, Hythe. He moved to Canterbury Road, Ashford and died in Ashford Hospital on 5 July 1945. Probate of his estate (£400) was granted to his nephew Nelson Wood, dairyman, the son of Llewellyn and Laura Wood.

Amanda Malvina Hammon nee Edwards was the daughter of William and Jane Edwards. She was born in Stoke Fleming, Devon in 1864 where her father farmed 170 acres. In 1884 she married

James Henry Ingram and had a son, Percival Henry Ingram, who was her executor. James died aged 24 in 1887 and by 1891she had married John Hodge, a farmer in Berry Pomeroy, Devon. In 1911 they were living in Bembridge, Isle of Wight, where John was manager of a dairy farm. Her marriage to Philip Hammon has not been found. When she died in 1940 in Hill House, Lyminge, (a sanatorium and workhouse) aged 76 her home address was 64-68 High Street, Hythe. She left £1,541.

Plot 447 Hobday and Mackintosh

Valentine Hobday was born I 1838 in Boughton Aluph, Kent, the eldest son of John Davis Hobday and Mary Austin. In 1851, aged 12, he was 'helper in the house' at Eastwell Rectorywhere the Rector had a cook and four maids. In April 1868 he married Sarah Peerless in Cheriton. They had 2 daughters and a son. In 1881 they lived with Sarah's father in Cheriton but by 1891 they were living in North Street, Hythe. Valentine was a gardener.

Plot 448 Fright

Also of/ Mary Anne/ wife of the above/ died December 8th 1919/ aged 91 years and 6 months/

Also of/ Harold William Fright/ [wh]o died/ aged [illegible]/[illegible] Departed (illegible)/ Just on (illegible)/ and in (illegible) on/ the other side.

And of Charlotte Fright/ daughter of William and Mary/ died 8th February 1937.

William Fright was the Stationmaster of Hythe in 1891. He was born in Newnham, Kent, the son of William and Charlotte Fright. In 1849 he married Mary Ann Day. Initially they lived in Newnham, where William was an agricultural labourer like his father and brother, but by 1855 William had become the Stationmaster in Salehurst, Sussex. He then went to Tonbridge in 1858, then to Barming by 1860. In 1881 he was stationmaster in Newington. After he retired he and Mary lived in Sutherland Rd., and then in Market Street, Hythe, where he died. His estate was £217.

Mary Anne Fright nee Day was born in Lenham, Kent, in 1828. After her husband's death she continued to live in Market Street (later renamed Dymchurch Road) with two daughters.

Harold William Fright was born in Whyteleaf, Surrey, in 1899. He married Ida Hutchinson in Stokesley, N. Yorks, in 1924. They lived in Chingford, Essex. Harold died on 29 January 1929 at the Railway Siding, Leyton, Essex.

Charlotte Fright was born in 1855 at Salehurst in Sussex. After leaving home she worked as a housemaid before returning to live with her mother by 1911. She remained in the house until her death.

John Bishopp was baptised in Wye, Kent, on 30 June 1833, the son of John & Frances Bishop. The family moved to Kennington soon after and by the time he was 17 he was an agricultural labourer living on a farm. In 1856 he married Amy Elizabeth Glayzier in Dymchurch and they began living in Brewhouse Square, Hythe where he worked as a labourer. In 1871 he was a brewer living in

Brewery Cottages. He and Amy had 7 children but she died in 1874. In 1876 he married Mary Crust and had another 3 children. By 1881 he was a labourer again, living in Rose Cottage, Bartholemew Street, where they lived till his death in 1896.

Mary Bishopp was born Mary Harriet Glayzier in Dymchurch in 1841. She was the sister of John's first wife Amy Elizabeth Glazier. Mary married James Crust in 1862, their only child, Florence Jane (see below), was born in 1863, and James Crust died in 1864, aged 26. During widowhood Mary worked as a monthly nurse; in 1871 she was nurse to the baby of the Mayor of New Romney while Florence lived with her grandmother, Elizabeth Glazier. She married John Bishopp in 1876 and after his death she lived in 15 Bartholemew Street, Hythe, with her step-daughter/niece, Catherine, and her youngest child, Harry.

Ellen Bishopp was born in March 1871, the daughter of John Bishopp and his first wife, Amy. After leaving school she worked as a housemaid.

Florence Baker was the daughter of Mary Bishopp by James Crust. She married Benjamin Bartholemew Baker in 1887. He was a baker and they had a son, Benjamin in 1890. After Florence's death Benjamin remarried and had a daughter.

Plot 451 Parsons

Inscription In/ affectionate remembrance of/ Emily the beloved wife of/ Charles W. Parsons/ who died March 2 (illegible)

Emily Parsons was born Emily Holtum in 1846 in West Hythe and baptised in Lympne in January 1847, the daughter of Isaac & Harriet Holtum. Her father was a farm bailiff. She married Charles William Parsons in 1866 and they had two daughters. One of these, Edith, is buried in plot 109 together with her father and his second wife. Emily died in 1871.

Plot 452 Loring

Inscription Sacred/ [to the} memory {of]/ Eliza the beloved wife of/ Oliver Loring Junr./ who died April 19th 1857/ in her 25th year

She sleeps in Jesus

Eliza Loring nee Horner was born in 1834, the daughter of John & Mary Horner. In 1851 her father was a boatman in the Coast Guard and the family was living in Fort Sutherland, Hythe. Her parents are buried in Plot 215 and two brothers in plot 214. On 11 May 1852 she married Oliver Loring in St Mary the Virgin, Dover. His father, also Oliver, was a retired Coast Guard Office and Oliver junior was a Coast Guard boatman. Oliver & Eliza had one son, Oliver, baptised in Folkestone on 27 July 1853.

Plot 453 Stevens

Inscription In loving memory/ of/ Edmund Matthew Stevens,/ who died December 19th 1907/ in his 61st year.

Also Fanny Julia wife of the above/ who died September 6th 1908/ in her 62nd year

Thy will be done.

Edmund Matthew Stevens' mother was Tamer Stevens who was born Tamer Fryer in Cobham Kent in 1814. She married a Mr Stevens and had Edmund Matthew in Gravesend in 1847. Edmund's father had died by 1851 and Edmund and his mother were living in Dover with her brother Robert. In 1871 they were still living in Dover. Edmund was a chemist and Tamer was an 'annuitant'. By 1880 they had moved to Eastbourne. They moved to Dover in the 1880s where Edmund had his own chemist's business. They moved to Hythe sometime after 1901, living in Seabrook Road where Edmund died leaving £4,736 personal estate.

Fanny Julia Stevens nee Drewett was born in Henley-upon-Thames in 1847, the daughter of John Drewett, wheelwright, and his wife Mary Anne. She married Edmund Stevens in Henley in 1873 and their first two children were born there . Another two were born in Eastbourne. After her husband's death in 1907 she moved to Folkestone where she died at 2 Martello Avenue leaving £455 personal effects.

Plot 454 Gilbert

Inscription [Illegible] Also of Jane Gilbert/ relict of the above/ born 7th September ..94, died .. March 1877.

Thomas Gilbert was baptised in Hythe on 30 June 1791, the son of Simon Gilbert (b. 1746 in Hythe) and Everell Ford who married in Hythe in 1774. In 1824 Thomas was a Watch & Clock Maker in Hythe. In 1861 he was a silversmith in the High Street. He died in 1869, aged 78, leaving personal estate of between £1,000 and £1,500.

Jane Gilbert was born Jane Davidson, the daughter of Andrew & Ann, in New Romney, Kent, and baptised there on 5 October 1794. She married Thomas Gilbert, in Hythe, on 5 November 1829. In 1871 Jane described herself as an annuitant and was a boarder with Samuel Elgar, boot manufacturer, in Hythe High Street.

Plot 455 Horton

Inscription (Part of 'Sacred to the memory of')/ Henry Horton/ officer of the Inland Revenue/ and son of Charles and Mary/ Horton (illegible)/ born November 26th 1840/ died March 13th 1865

He is not dead but sleepeth.

Henry Horton was born in Hythe High Street where his father, Charles Horton, had a pub. By 1851 his father was running the Bell Inn in Newington. His father also had a builder's business employing 5 men in Newington and Henry trained as a carpenter. He then got a post as an Inland Revenue officer. The family seem to have stayed in Newington after his father died in 1861 as Henry was living there in 1865 when he died. His parents are buried in Plot 456

Plot 456 Horton

Inscription Sacred/ to the memory of Charles Horton/ of this town/ died Augt. 2nd 1864/aged 52 years/ (illegible) and children (viz)/ Charles Henry. Mary Ann/ and Catherine

Also of Mary Ann/ wife of the above who died/ June 18th 1874/Aged 73 years

God has given us.

Charles Horton was the son of John and Mary Horton and was baptised in Hythe on18 May 1812. In 1841 he was a publican in Hythe High Street but by 1851 he had taken over the Bell Inn in Newington. He also traded as a master builder in Newington. His older brother Henry is buried in Plot 121.

Mary Anne Horton nee Stone was the daughter of Edmund and Elizabeth Stone and was baptised in Mersham, Kent, on 30 January 1803. She married Charles Horton in Hythe on 7 September 1834 and bore him 7 children in the next 11 years. After she was widowed in 1861 she continued to live in Newington for a time but by 1871 she was living in St John's Almshouse in Hythe High Street

Plot 457 Kyle

Inscription Henry Stopford/ Kyle Esq./ Barrister/ died 5 January 1865 aged 66

Henry Stopford Kyle was born in 1808, the third son of the Rt. Rev. Samuel Kyle, Bishop of Cork and Ross from 1831 to 1848, and his wife Anne. Henry entered Trinity College, Dublin in July 1824, aged 16, and graduated B.A. in 1829 and M.A. in 1832. He was called to the Bar in Lincoln's Inn in 1836. In 1839 he married Julia Esther Green and they had one son, Henry Egerton Kyle, in 1840. In 1848 he was appointed Registrar of his father's diocese but seems to have lived and worked in London. By 1861 he had ceased to practice as a barrister and was a lodger in Folkestone with his son.

Plot 458 Buller

Inscription Edwin Buller born December 3 1818 Died December 26th 1895.

Edwin Buller was baptised in Graveley, Cambs, in May 1820. He was probably born in Haddenham, Cambs, but he gave varying information about his birthplace and his age. This evasion may well be due to a bankruptcy petition against him in Cambridge in 1851. He was the son of William Nicholas Buller, said to have been a ship's surgeon at the Battle of Trafalgar, and Mary Ann Burrows. In 1841 Edwin was an assistant surgeon in Haddenham. According to the bankruptcy petition he was a student at Charing Cross Hospital and the London Hospital. In 1848 he married Eliza Webb in Southampton. She was a teacher of dancing in Cambridge and bore him a son, Edwin. She died in 1860 and in 1864 he married Louisa Hill in Islington who bore him four more children before her death in 1870. In 1871 Edwin was in Exeter with his eldest son by Louisa. At some point he went into partnership with another doctor in Ely, Cambs, which was dissolved in 1885. Edwin continued the practice but by 1891 he was in Martley, Worcs. He died at 3 Park Rd., Hythe. [

Plot 459 Reynolds

Inscription Sacred/ to the memory of/ George Reynolds/ who departed this life/ October 4th 1857/ aged 42 years

This stone was erected by the/Brethren of Prince Edwin's Lodge / No 1—Hythe/ in testimony of their regard/ and esteem for him as /a/Brother Mason.

Also of Annie his wife/ who died August 4th 1892/aged (illegible) years.

And in memory of/Emily Martha/ daughter of George and Anne Reynolds/ Died Sept 2nd ?1905/ Aged 58 years.

George Reynolds was a boot maker in Hythe High Street. He was born in Hythe in c.1815.

Anne Haddon Reynolds nee Stokes was the daughter of Henry Stokes, a tailor. She married

George Reynolds in 1842. She was an inmate in Elham Union Workhouse in 1881.

Their daughter, **Emily Martha Reynolds**, was baptised in Hythe in January 1848. She went to the Royal Freemasons School in Battersea, London. She worked as a dressmaker in Dover and as a cook in Folkestone.

Plot 460 Reynolds

Inscription Sacred/ to the memory of/ William Reynolds/ who died 30th April 1864/aged 80 years.

Also/ Eliza/ daughter of the above/ who died 28th September 1875/ aged 64 years.

William Reynolds was born in Ash, Kent, in c.1790. In August 1807 he married Hannah Portwine in Hythe. William was a baker in Hythe High Street.

Their daughter **Eliza Reynolds** was baptised in Hythe in September 1810. After her father's death in 1864 Eliza carried on his business till her own death.

Inscription In loving memory of/ Norris Elvey/ who died (illegible) July 1868/aged 88 years.

Also of Sarah his wife/ who died 16th May 1857/ aged 71 years.

Norris Elvey was baptised in Denton, near Dover, in May 1781, the son of Norris & Elizabeth Elvey. He married Sarah Dodd in December 1809 in Adisham, Kent, Initially they lived in Cheriton but by 1824 Norris was a baker in Hythe High Street where he remained till his death.

Sarah Elvey nee Dodd was born in Adisham, the daughter of Isaac & Hester Dodd, and baptised in Bishopsbourne in September 1786.

Inscription In loving memory of Thomas William Fagg who passed on Jan. 24 1910 aged 54.

Also Elizabeth Ann his wife who passed on Oct. 6th 1937

Thomas William Fagg was the son of John and Elizabeth Fagg. He was born in 1855 in Stanford, Kent, where his father was an agricultural labourer. When he was about 1, the family moved to Swan Lane in Sellinge, Kent, and finally to Hythe. In 1881 Thomas was a general labourer and he and his older brother were boarding with a family in Twiss Road. In 1885 he married Elizabeth Ann Philpott. Thomas, Elizabeth and their two children lived with his widowed mother at 2 Albion Place, Hythe. Thomas and his brother John were market gardeners. By 1901 Thomas was a self-employed dairyman and market gardener. At some point he was admitted to the East Kent County Asylum, Chartham, where he died.

Elizabeth Ann Fagg nee Philpott was born in Monks Horton, the daughter of Ingram & Sophia Philpott, and baptised there in July 1859. Her father was an agricultural labourer. In 1871 John Fagg, a 15 year old agricultural servant, was a lodger with the Philpotts; he may have been her future husband's elder brother. In 1881 Elizabeth was a cook in a boarding school for girls in Sutherland House, Stade Street, Hythe, cooking for 3 teachers and 17 pupils. After her husband's death she continued to live in Albion Terrace

Plot 466 Johnson

Inscription In loving memory of/ Robert Johnson/ died in hospital U.S.A./ May 7 1927 aged 24 years/ late SS "Belgenland"/ Red Star Line.

Also Albert Johnson/died Nov. 16 1923 aged 55 years

Father and son at rest

Also Emily Ann/ wife of the above/ died Oct 1st 1945 aged 76 years

Reunited

Albert Johnson was born in Stelling Minnis, Kent, in 1868, the younger son of Robert & Eliza Johnson. He was employed as a carter. In 1891 he married Emily Ann Marsh and they had 8 children, two of whom died young. They lived in Theatre Street, Hythe.

Emily Ann Johnson nee Marsh was the eldest child of Henry & Alice Marsh. She was born in Alkham, Kent, and baptised there in April 1869. Before she married she was the cook in the household of a tailor, outfitter and pawnbroker in Folkestone, cooking for the family, two tailors and the housekeeper and housemaid.

Robert Johnson was born in Hythe in 1903. He was brought up in Theatre Street and went to sea at the age of 18 as a waiter. He joined the SS "Belgenland", based in Antwerp, in April 1923 after her conversion from a troopship into the Red Star Line's largest and most luxurious ship. For most of the time he sailed in her between Antwerp, Southampton and New York, but in December 1924 she went on a 133-day world cruise, advertised as "The Largest Ship to Circle the Globe". His last voyage started in Antwerp in November 1926, calling at New York in early December then going elsewhere till returning to New York on 24 April 1927.

Plot 467 Blatcher

His parents are buried in plot 472 and his sister Elizabeth (Ravenscroft) in plot 474.

Henry Huggett was baptised in St Mary's, Dover, on 6 September 1811, the son of William & Jane Huggett. In 1841 Henry was a turner, living with his parents and sister Sarah. In 1851 he was living with his younger brother William in Adrian Street, Dover. In 1891 he was 'living on means' with Sarah in Hythe. He died in Kingchurch House, Theatre Street, Hythe and left effects worth £1,193. His executors were William Charles Capon, tailor, Charles William Capon, bootmaker, and Henry Capon, tailor. He moved to Scene Farm prior to 1891 whilst retaining his butcher's business in the High Street. When he died in September 1895 he left effects worth £1,396.

Elizabeth Emma Horton, eldest daughter of Benjamin Bassett Horton, variously described as 'house owner', 'living on own means' and 'private gentleman'. Henry Usher of 14 Ormonde Rd., Hythe, died at Hill House, Lyminge (a sanatorium and workhouse), on 24 February 1937, survived by his wife. He left effects worth £3,026.

Emily Constance Hallum was born in Wormingford, Essex, in 1855, the daughter of John Thomas Lay Hallum and Sarah Matilda Cobbold. Her father farmed 430 acres there employing 15 men and 2 boys. He died in 1867 and her mother married James Swaine in 1873, a clergyman. Emily lived with her mother till her mother died in 1895 when she moved to Park Road, Hythe where she died leaving effects worth £3,810.

They had four children together before he died in 1846, and lived in Hythe High Street. On 20 September 1847, at St Mary the Virgin Dover, Jane married Arthur Howett. They also lived and worked in Hythe High Street and Jane had another three children. She died in 1864.

James Henry Trueman, 'Jim', was the first son of Henry William and Rosanna Trueman. Jim became a tram conductor. He married Cecilia Powell, a Hythe girl, in 1899 and they had two children, Georgina, born in 1900 and James, born 1903. In 1911 they were all living at Frampton Road, Hythe. The family emigrated to Canada in

1913. Cecilia died there at Bayham, Elgin, Ontario on 6 April 1915, aged 37. Jim enlisted in the Canadian Army Medical Corps in 1916. Shortly before this, on 17 October 1916, he married Violet Reid in Frontenac, Ontario. He sailed for England and was stationed at Westenhangar, near Hythe. His health then gave way and he spent several months in the Moore Barracks Hospital at Shorncliffe Camp. Five weeks before his death he was invalided out of the Army. His two children apparently returned to England with Violet, as they were present at his funeral. Unfortunately, it transpired that he had not, in fact, been legally married to Violet. She had 'married' several other Canadian servicemen in the hope of getting their separation allowance when they were on active service and their pension if they were killed. Unsurprisingly, she disappeared without trace. Jim is named on the Brookwood Memorial 1914-1918 Wall, Surrey as one whose final resting place is unknown, but the Commonwealth War Graves commission intend to mark his grave in Hythe.

Rosanna Trueman nee Burrows was born in Ashford, the eldest child of James and Abigail Burrows. She and Henry William Trueman had three sons

Henry William Truman was born in Kent. He became a groom and later a coachman, living with his family in Theatre St, Bartholomew St and North Road.

Frances Cloake nee Blatcher was born in 1821 in Hythe the daughter of George Blatcher (1781-1841) and Mercy Austen. Her sister, Mercy Ward, is buried in Plot 113.

Thomas Burden was born in 1829 in Biddenden, Kent, the son of Thomas, a thrasher, and Eliza Burden. In 1857 he married Sally Anne Munk. He was a grocer in Hythe High Street, employing 7 boys in 1861. By 1871 they had three children and shared their house in the High Street with a governess, two grocer's assistants and a housemaid.

Sarah Ann Burden nee Munk was the daughter of Edward & Ann Munk. Her father farmed 200 acres in Frittenden. She was christened there on 29 June 1828. After her husband's death she continued to live in Hythe with two unmarried daughters. She left effects worth £1,562.

Maria Bull nee Cobb was born in Ashford, Kent, the daughter of Thomas & Mary Cobb, and baptised there on 26 January 1821. She married Alfred Bull in Ashford in 1845 and lived in Hythe High Street where Alfred was a draper. Alfred was born in 1815 in Lewes, Sussex, the son of Harry & Mary Anne Bull.

Plot 512 Bull

Maria Bull was baptised in All Saints, Lewes, on 11 October 1805. She was the older sister of Alfred Bull (see Plot 511) and came to Hythe to keep house for him and his five children when his wife Maria died in 1858. Until then she had lived in Lewes with her younger sisters, Frances and Mary Ann. She left effects worth under £600.

Frances Bull was baptised in St Michael, Lewes on 9 December 1821. In 1841 she was living in Lewes with her mother and was a dressmaker's apprentice. She was still in Lewes in 1851 living on an annuity with her sisters Maria and Mary Ann. After Maria went to Hythe , Frances went to live with their elder brother Richard Bull who was a grocer and Alderman in Arundel, Sussex. She died in Hythe but her last home was in Chailey, Sussex. She left effects worth under £600.

Ann Collinson nee Jay was born in Hythe. She married Thomas Ellison Collinson in Hull on 29 July 1824. There were no children. After her husband's death she lived with a niece in Sandgate Road.

Emily/wife of Bertram Winnifrith/Dec.7.1864-Sep.17.1894 Alfred Winnifrith was the son of Thomas & Lucy Winnifrith. He was born in Penshurst, Kent on 22 April 1842. He came to Hythe in 1863 and in December 1863 he married Mary Baker in the town. He returned to settle in Prospect House, Hythe in 1865 and became Headmaster of Prospect House School till 1874 when he went with his family to Oxford but returned to Hythe in 1875. In 1876 he was ordained Deacon by the Bishop of Ripon and became Assistant Curate of St John's Cleckheaton, Yorkshire. In 1878 he was appointed First Incumbent of the newly-formed Parish of St Luke's, Cleckheaton. In 1885 he became the Rector of Mariansleigh, Devon. He resigned that living in 1913 because his wife's "delicate state of health has not permitted he to live at Mariansleigh for several recent winters" and returned to Hythe. He wrote two books, "Men of Kent and Kentish Men" and "The Fair Maids of Kent" and erected the tablet on Prospect Lodge recording that it was the birthplace of a Lord Mayor of London and another in the High Street to the memory of the inventor of the steam screw propeller.

Mary Winnifrith born Mary Baker in Tiverton, Devon, the daughter of Thomas Baker..

Emily Winnifrith was born in Plymouth, She was the daughter of John & Rosamund Dennis. Her father was a publican in Plymouth in 1871. By 1881 he had moved to Plympton St Mary, Devon, where he farmed 17 acres. Emily was his housekeeper. She married Alfred and Mary Winnifrith's second son Bertram in Plymouth in 1891. They had a daughter born in 1892 in Hythe, Ethel Mary Rosamund Winnifrith. After her mother's death Ethel seems to have lived with her grandparents. Her father remarried in 1897. In 1921 Ethel emigrated to Nelson, British Columbia, Canada to be a companion there to a Mrs Boyer. In 1922 she married Norman Leslie Denny in Nelson and died there in 1978.
