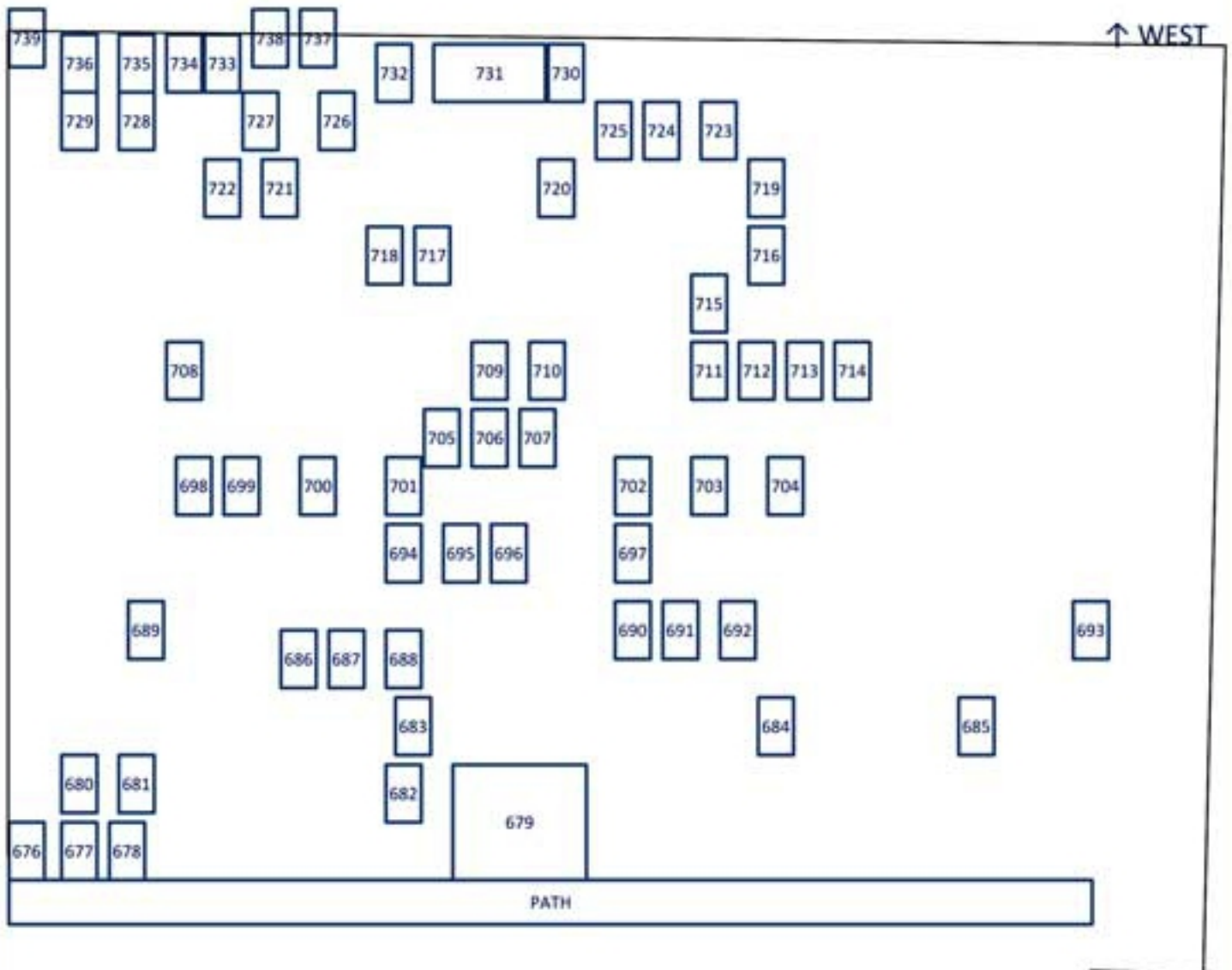

Elizabeth Bishop was the wife of Major Henry Bishop. He was in the 64th Regiment of foot, and at some time after 1808 on half pay in the Provisional Militia. He and Elizabeth had houses in Harrogate and London. They had no children and Henry's estate was left to his nephews

Mary Rayner nee Hughes was born in Mersham, the daughter of Edward and Judith Hughes. She was baptised there on 15 February 1748. She married John Rayner on 14 December 1780.

Mary Rayner (junior) was the daughter of John and Mary Rayner. She was born in Mersham and baptised there on 15 June 1783. She lived in Hythe High Street and was of 'independent means'.

John Rayner was born in Charing in on 5 December 1747, and baptised there on the last day of the year. He was the son of William and Mary Rayner and became a fellmonger, at first in Mersham, but later in Hythe. He married Mary Hughes in Mersham 14 Dec 1780. She is buried in plot 671 together with their daughter

Henrietta Cotgrave/departed this life/on the 8th of May 1838/aged 3 years and 4 days

Rowland Cotgrave was the son of Rowland Burdon Cotgrave, a naval officer, and his wife Emily Henrietta nee Ellis. He was baptised in Charlton,

London, on 21 January 1834 and died in Hythe, where the family lived at Fort Sutherland

Henrietta Cotgrave was born in Folkestone and baptised there on 17 June 1835. She and her brother had an older sister, Emily.

Edward Watts was the second son of James and Hannah Watts. He was born in 1804, and became a solicitor, with offices in Great Conduit Street. He was elected Town Clerk and Clerk of the Peace during his father's second term as Mayor, and retained these posts until his death. He was one of the founder members of the Elham Valley Railway Company and worked tirelessly to bring the railway to Hythe, although he did not live to see its opening in 1874.

He married Amelia Bunn of Reigate on 30 September 1840. They had nine children. Edward was asthmatic all his life, and an attack of bronchitis proved fatal and he died on 1 June 1867. His brother James is buried in plot 322.

Ernest Edward Watts was the eldest son of Edward and Amelia Watts. He was born in Hythe and baptised there on 11 July 1848. He died aged 11 on August 30 1859.

In memory of Eliza widow of Lieutenant George Dyer/who died illegible/on the 22th of illegible 1852 remainder illegible

George Dyer was born in 1792 in Stoke Damarel, Devon. His father, George, had fought with Nelson at the Battle of Trafalgar and his mother, Susanna was the daughter of Alexander Innes, the Commanding Officer of Port Royal, Jamaica. George had joined the Royal Navy by 1815 and was based in Plymouth, near his home, which he visited often. He had at this time a particular interest in ancient history. Thanks to his father's efforts he was promoted to Lieutenant and appointed to the *Pique* frigate in Portsmouth, to his mother's distress. By 1826, still unpromoted further, he was commanding officer at Fort Twiss, responsible for the coastal blockade against smuggling. In the early hours of Wednesday 5 April, the station received reports of heavily armed smugglers in the area. Patrolling the beach, one of his men, hearing gunshots, apparently fired in response but shot Lieutenant Dyer dead. Although the man, John Lemon, claimed it was an accident, he had not been ordered to fire and was charged with manslaughter and court martialled. He received a reduced sentence of 14 days at the request of George's wife who stated she believed it was an accident. George was buried with military honours, including a firing party of 103 men. His uncle is buried in plot 664.

Eliza (or Elizabeth) Dyer was born in about 1799 in Shoreditch. The date of her marriage to George has not been established. After his death, she married George Elgar, a surgeon ten years her junior, on 6 April 1829 at Hanover Square, Westminster. There were no children of either marriage. She died in 1852 at Romney Place, Maidstone.

Timothy Hugh Rowlatt was born in Kettering. At the age of fifteen, he was apprenticed to his father, a woolcomber, who shortly afterwards died. He continued in this trade, working for his mother until July 1792, when he moved to Leicester to work on his own account. In February 1793, he joined the Army, and served for five years. He then moved his family to Saltwood and later to Hythe where he rented a house at £13 a quarter. Falling on hard times, he was obliged to seek parish relief in 1803.

Sarah Rowlatt nee Clarke married Timothy Hugh Rowlatt in Lyme Regis on 23 February 1794. They had one child in Brighton, and at least two others were born in Dymchurch. After her husband's death she lived in Chapel Street.

Martha Chamberlain nee Illenden was born in Womenswold and baptised there on 24 May 1774. She was the daughter of William and Sarah Illenden. She married Richard Chamberlain, a bricklayer and St Leonard's Parish Clerk, on 9 May 1801 in Saltwood. They lived in Hythe High Street. Of their six children, two are buried with her husband in plot 582; the other four are those named here, although the word 'children' is missing from the inscription

Richard Chamberlain was born in Hythe and baptised there on 26 October 1806. He became a bricklayer like his father and married Elizabeth Burden on 22 August 1829. There were no children. They lived at first in Oak Walk, Hythe, then later moved to Elizabeth's birthplace, Westwell near Ashford, and finally to the 'Farmers Arms' at Mersham where he held the licence. By 1881 he had been confined to Ashford

Workhouse, although Elizabeth was living with her sister in Westwell. He died later that year.

William Chamberlain was baptised in Hythe on 20 January 1809. Like his father and brothers, he became a bricklayer. He married Susannah Catherine Maria Cumming in Hougham on 17 June 1827. They lived in Stade Street, Hythe. They and their six children emigrated to Australia in 1841 on board the '*Lalla Rookh*', with another child being born at sea. William died in Glenmore Road, Rushcutters Bay NSW on 22 April 1855

Plot 693 Huckstaff and LLOYD

Inscription John/son of William/Lloyd/of the Royal Glamorgan/ Militia and Anne/ his wife/died illegible December /1815 aged 5 years &/illegible months

Mary/daughter of Henry/& Esther Huckstaff/of the Royal /Glamorgan Militia/died 30th December 1815/aged 11 months

John Lloyd's father was posted to Saltwood Barracks at the time of his death.

Mary Huckstaff was baptized 18th April 1813 at Canterbury, Kent, the first child of Henry Huckstaff and Esther Huckstaff nee Felton who had married two years previously in Bristol.

In March 1812, whilst at Bristol, the Royal Glamorgan Militia was converted to Light Infantry. On 29 June the Regiment was ordered to the East Coast and marched via Bath, Wiltshire & Berkshire to Woodbridge Barracks, Yarmouth. However they were not there long before being sent to Ramsgate, Kent in September of the same year. The period from 1813 – 1815 has it in Dover, Hythe and Canterbury.

Inscription *...Iam Ga...who was Bay... and Mayor for the Yeare 1650 ... Ancie ... he... Yeare is.... departed this mortall life on the LORDS day the 23 of February 165...being of the age of 52 yeares*

William Gately was born in about 1599, the son of John Gately, and his first wife Phillice, nee Possingham, who had married in Hythe in 1598. Although a blacksmith, John was comfortably off, owning a large hall house in Hythe whose furnishings and effects alone were worth £68, at the time of his death. William married Ann Dryland on 2 October 1627 in Wye. Their first child, John, was baptised in Hythe on 31 August 1628, but is not mentioned in his father's will, so presumably died young, as did their second son and third sons, both called William. Their only daughter, Elizabeth, to whom William left most of his estate, was baptised in Hythe on 11 Jul 1630. William was a jurat of Hythe and, in 1850, Mayor. He was churchwarden of St Leonard's Church in 1639 and 1641 and also a tradesman, with several apprentices, whom he remembered in his will. Like his father, he was in comfortable circumstances and owned land in Hythe, Saltwood and Bilsington. He was also the owner of silver plate and a 'feather bedd, well furnish'd'.

Jane Duff Denne nee Falconer was born in London on 17 March 1804, the daughter of John Falconer and his wife Caroline. Her father was appointed consul to Leghorn (Livorno) in 1814, a position he held for many years. She married Thomas Denne

at St George, Hanover Square, London on 17 November 1834. They did not have children. Her husband is buried in plot 528.

John Gibbons was a carpenter who, amongst other things, carried out work for the military in Hythe. Their daughter and son are buried in plots 711 and 712 respectively.

Marjory Wallace Mackechnie was born to Charles Wallace and Stewart Wallace in Arbroath, Angus, Scotland in 1792, the second of five children. On 4 April 1816 Marjory married Andrew Mackechnie in Bellary, Karnataka, India. They had eight children. Two in Bangalore, three in Madras, two in Angus and their only surviving daughter in Hythe, where they had settled

Edward Dixon Clarke was baptised on 21 July 1805 in Hythe, the second son of John and Mary Clarke who are buried in plot 725. He became a cordwainer (shoemaker) and lived with his family in Hillside Street, Hythe.

Elizabeth Betson Clarke nee Hyham was the daughter of James Hyham and his wife Anne, and was baptised in Hythe on 11 May 1804. Her father was the town gaoler for a number of years. She married Edward Dixon Clarke in the town on 11 January 1830. After her husband's death, she remained in Hillside Street and supported her children by working as a monthly nurse.

Emily Clarke was baptised on 2 July 1837 in Hythe

NB Although the stone says that Edward and Elizabeth Clarke left 7 children, 8 are named. This may be because Helen was born after Edward's death.

Dorothy Mannings nee Brown married Thomas Mannings on 29 September 1730 in Saltwood. Her two children were born in Hythe in 1732 and 1734.

On the left lie the remains of/ Thomas Stokes, who died 4th November 1852/aged 55 years

Elizabeth Shipwash nee Stokes was born in Lylinge. She was married to William Shipwash, a tailor with a home and premises in Hythe High Street. They had a son and a daughter. Her parents are buried in plot 743 and her sister Mary in plot 621

Thomas Kennett Stokes was the son of Elizabeth Stokes (later Shipwash) and was born in Lyminge, where he was baptised on 23 April 1797. He became a farmer, living near Hythe, and was married to Mary. They had three children.

Plot 730 Nelson

Inscription *In memory of/James Nelson, formerly of the 78th West Highlanders,/and the Royal Staff Corps who after/serving his King and Country in Holland, Spain and France from 1800/ to 1821 settled at Hythe and died/April 29th 1849 aged 65 years*

Also of Henry Nelson/grandson of the above/Sub Superintendant Land Transport/Corps who died before Sebastapol/ June 4th 1855 at the early age of 17 years.

Enter not into judgement with Thy /servant O Lord

James Nelson was born in Scotland in about 1786. During his army career he saw action at Nijmegen, in Holland, at Vittoria and Corunna in Spain. In later life, he became a beerseller, dealer and chapman (trader or peddler)and grazier with land on the Innings between the town of Hythe and the coast. He lived with his family in Shoemakers Bridge Place, at what was to become the Nelson's Head Public House.

Jane Nelson nee Hills was baptized on 3 April 1785 at Chiddingstone, Kent, the daughter of John Hills and his wife Elisabeth. She married James Nelson on 13 August 1811 at Newington-next- Hythe. They had three sons and a daughter, born in Hythe and France, as Jane travelled with her husband. Their son Henry and his family are buried in plot 120, another son James in plot 201, and other descendants in plot 70.

Henry Nelson was the son of Henry Nelson (the second son of the James Nelson buried here) and Mary Ann Nelson nee Back. He was born in Hythe and worked as an errand boy before joining the Army.

Emma Charlotte Day was the daughter of Albert and Susannah Day who are buried in plot 572. She was born in about 1870 in Hythe where she lived all her life and where she died in 1940

Also of Mary Susannah Day/great granddaughter of Henry Rook and/Susanna Day/born Feb 23rd 1861/died April 18th 1945

Susanna Day nee Burgess married Henry Rook Day in Christchurch on 24 July 1790. They had at least seven children, who, apart from James who is buried here, are in plots 133, 572, 576 & 577

Mary Susannah Day was the daughter of Albert and Susannah Day who are buried in plot 572. Her father was a carpenter and local alderman. She died in Devon

3) Inscription *In memory of Henry Rook Day/so of William and Ann Day/born Nov 5th 1767/died Oct 17th 1849*

Also of Henry Albert Day/great grandson of above/late rector of Little Berkhamsted/born Feb 26th 1863/died illegible

Henry Rook Day was born in Christchurch, Hampshire and baptised there on 18 Feb 1768. He became a mariner and settled in Hythe, living in Stade Street.

Henry Albert Day was the son of Albert and Susannah Day who are buried in plot 572 After studying theology, he became a clergyman in the Church of England, at first in Camberwell, and was appointed Rector of Little Berkhamsted in 1908. Although he was in 1919 engaged to be married to Sarah Edith Rowling, the marriage did not take place. He died in Devon in 1951.

James Bell was inducted as vicar of Lympe in 1802. In retirement he lived in Hillside Road, Hythe. He died on 30 December 1834

Julia Harrison Bell was baptised in Hythe on 12 May 1806. She died on 20 September 1816. She was the couple's third daughter

Edmund Harrison Bell died in on 6 January 1808. He was the couple's only son.

Mary Bell nee Harrison married James Bell on 12 January 1799 in Hythe. The couple had five daughters and a son.

Also Edmund Stokes/ who departed this life/ the 8th of [July] 1834 / aged 87 years.

Jane Stokes nee Rigden lived in Lyminge at the time of her marriage to Edmund Stokes on 27 October 1771. Their four daughters were all baptised there, Jane on 29 March 1772, Elizabeth on 16 April 1775, Mary on 16 August 1778 and Ann on 24 February 1782.

Edmund Stokes was baptised in Hawkinge on 31 May 1747, the son of Thomas & Mary Stokes. Edmund and Jane had probably moved to Hythe by 1801 when two of their daughters married there, Jane to William Sisson and Mary to Thomas Marshall (see plot 621). Their other two daughters married in Hythe in 1804, Elizabeth to William Shipwash and Ann to William Marshall. Elizabeth is buried in plot 729.
